SAN DIEGO,Sept. 10,2025 (GLOBE NEWSWIRE) -- NeoVolta Inc. (NASDAQ: NEOV) has signed a letter of intentto acquire strategic assets of Neubau Energy,positioning the combined entity to capture significant share of the rapidly expanding residential energy storage market while avoiding anticipated 2026 battery import tariffs that could exceed 28%.
