Will my items be allowed to enter New Zealand?

An item may meet the biosecurity requirements enforced by MPI but it may not meet some other types of requirements enforced by other government agencies at the border. You may need to contact multiple government agencies to check whether your items are likely to be allowed to enter New Zealand.

Can a business bring goods into New Zealand for resale?

Businesses and commercial entities intending to bring goods into New Zealand for resale must declare these items to the New Zealand Customs Service. Failure to do so can result in penalties, fines, and even seizures of goods.

What do I need to do if I bring goods into New Zealand?

What items do I need to ship to New Zealand?

You will need to declare any packages that include any natural foods, plant materials, animal materials (including hunting trophies), dried flowers, wood, seeds, straw, bamboo, and any items containing unprocessed wool or feathers. Do commercial samples need to be declared to New Zealand Customs?

Commercial samples,including prototypes,demonstration models,and display items,must be declared to the New Zealand Customs Service to comply with regulations and avoid potential penalties. Failure to declare these items can result in fines,delays,or even confiscation of goods.

What is an import clearance in New Zealand?

An import clearance is the procedure where the details of the imported goods are provided to Customs and MPI, the payment of any charges is made, the necessary risk screening and actions are completed, and the goods are authorised to enter New Zealand.WHAT

For imports valued at NZ\$1,000 or more, a supplier code is required. You can search our database, which is updated daily, to see whether your supplier is registered and has a code.
