Which country exports the most solar panels to the EU?

As Fatih Birol, the executive director of the IEA, was quoted by The Guardian as saying, "If I could sum this [trend]up in two words they would be: China, solar." China is by far the largest exporter of solar panels to the European Union, accounting for 98% of all EU imports in 2023, new data from Eurostat has shown.

What was the EU export value of solar panels in 2023?

The EU import values of solar panels and liquid biofuels in 2023 were much higher than the corresponding EU export values which were EUR0.9 billionfor solar panels and EUR2.2 billion for liquid biofuels. By contrast,the EU export value of wind turbines in 2023 (EUR2.0 billion) was much higher than the corresponding value for imports.

How much does a photovoltaic panel cost?

Mainstream Photovoltaic Panels: Average price of EUR0.10/Wp, down 9.1% month-on-month. Low-Cost Photovoltaic Modules: Average price of EUR0.060/Wp, a decrease of 7.7% compared to the previous month. These figures underscore the significant pressures in the photovoltaic market, as price reductions strain margins to unprecedented levels.

Trends in EU PV Installations (2024-2025) The EU PV market demonstrated steady yet modest growth in 2024, with an estimated 64 to 65 GWdcof new PV capacity installed - a slight increase of ~5% compared to the 61.9 GWdc installed in 2023, according to EUPD Research calculations.
