Should the Energy Department cut funding?

Some Republicans,however,urged the Energy Department to make cutsdespite the potential economic hit to their states and districts,noting that many of the projects may be untenable even with the federal support. Sen. John Hoeven (R-N.D.) said he supports narrowing grant funding to "projects that are committed and are still viable."

Does DOE funding energy research need to be cut?

Rep. Morgan Griffith (R-Va.), who chairs the environment subcommittee of the Energy and Commerce Committee, said he supports DOE funding research into all forms of energy, but there is a "huge group" of non-research grants that need to be cutto get federal spending under control.

Why did Democrats cut funding for energy hubs & other energy projects?

Democratic lawmakers argued that cutting funding for the hubs and other energy projects would be hypocritical to Republicans' stated goal to increase U.S. energy output-- and would be another example of the Trump administration's legally dubious effort to impound congressionally appropriated money.

Why is long-duration energy storage important?

Long-duration energy storage is widely regarded as critical to deploying the large amounts of intermittent wind and solar resources needed to decarbonize the global electricity supply. Grid-scale batteries now in the market, mainly lithium-ion, can typically only store up to four hours of power.
