LG Energy Solution is evaluating all options in this regard, including issuing warning notices or filing patent infringement lawsuits against those infringing on its patents. At the same time, it will also commit to driving fair competition in the industry by establishing a legitimate battery patent licensing market.

Did CATL infringe a patent on secondary battery technology?

What's new: CATL has sued CALBagain, this time in the Hangzhou Intermediate Court, for infringing on a patent related to secondary battery technologies. In the same suit, it also alleges that Hangzhou Pengxing Automobile Sales Service Co., Ltd. has infringed its top cover component patent.

Did Tesla infringe a battery patent?

October saw CALB bring its first counterclaim against CATL for 1 billion Chinese yuan (US\$136 million),in which it alleged that the EV battery giant and Tesla Automotive Sales and Service (Wuhan) Co.,Ltd. infringed four of its own battery patents.

Could a patent dispute affect the battery industry?

Industry analysts suggest that patent disputes like this could hinder competitors' market expansion and R&D efforts in an increasingly competitive battery market, with expectations of more cases to come in future. This content is protected by copyright and may not be reused.

How much damages does CALB claim for a battery infringement?

The largest claim within the lawsuits relates to liquid-cooled modular battery systems, with CALB seeking RMB 560 million(EUR73 million) in damages. In its filing, CALB required that CATL and related entities immediately cease the alleged infringements and pay compensation for economic damages and litigation costs.
