Does France have a pumped storage power station?

Pumped Storage: France has a single pumped storage power station- The Grand'Maison Dam capable of absorbing 1.8GW and delivering 2.4GW. Unlike the UK France only records the energy beng stored,not delivered. That is included in hydro. In general it is replenished whenever there is surplus power on the grid. Solar: This is the metered solar farms.

How much will France invest in the electricity grid in 2024?

The annual investment rate in the electricity grid will need to more than triple in the next five years, to 7.5 billion euros from 2.3 billionin 2024, still less than plans in neighbouring Germany, the report said. France plans to build six new nuclear reactors that are expected to help power future electrification.
