How many lithium batteries can a consignment contain?

MUST NOT contain more than 5 kgof lithium cells or battery packs. Must be properly identified with a lithium battery mark. I declare that the contents of this consignment have been properly prepared, and are packaged, marked, and labeled correctly, and are in all respects in proper condition for transport.

How many lithium ion batteries can a shipper consign?

The following limitation applies to consignments: A shipper is not permitted to consign more than two packagesof lithium or sodium ion batteries contained in equipment under Section II of PI 967,PI 970 and PI 978 where there are no more than 4 cells or 2 batteries in the package without the application of the battery mark on the package.

Do I need to mark a package of lithium metal batteries?

For lithium metal batteries contained in equipment, the mark need not be usedprovided (a) the package contains no more than 4 cells or 2 batteries, and (b) the consignment contains no more than two packages of lithium metal batteries contained in equipment.

Are lithium ion batteries rechargeable?

Lithium ion (Li-ion) batteries are rechargeable. Sometimes called "secondary lithium batteries" Includes lithium polymer (Li-Po) batteries These batteries are often found in common electronic devices such as cell phones and laptops Lithium metal batteries are generally non-rechargeable. Are lithium ion batteries packed with equipment?

E.11 I have lithium-ion batteries packed with equipment (PI 966, Section I) where the lithium ion batteries are packed in a UN specification fibreboard (4G) box and then that box is packed with the equipment in a fibreboard outer packaging. Is this an overpack?

Can I ship a lithium ion battery?

Regulations difer depending upon what type of lithium battery you are shipping(lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipments of UN3090 or UN3480 in air services.
