

Peak and frequency regulation prices of energy storage power stations

Do energy storage stations improve frequency stability?

With the rapid expansion of new energy, there is an urgent need to enhance the frequency stability of the power system. The energy storage (ES) stations make it possible effectively. However, the frequency regulation (FR) demand distribution ignores the influence caused by various resources with different characteristics in traditional strategies.

What are the different types of energy storage stations?

From a functional standpoint, the energy storage stations within the cluster can be categorized into three distinct types: frequency regulation energy storage stations, peak shaving energy storage stations, and hybrid energy storage stations capable of both peak shaving and frequency regulation functionalities.

Can small capacity energy storage power stations compete for frequency regulation services?

At present, China's small capacity energy storage power stations cannot be allowed to compete for frequency regulation services, but the establishment of auxiliary service markets such as frequency regulation and standby is conducive to guiding investment to improve the flexibility of power systems [19,20,21,22,23,24,25].

What is frequency regulation power optimization?

The frequency regulation power optimization framework for multiple resources is proposed. The cost, revenue, and performance indicators of hybrid energy storage during the regulation process are analyzed. The comprehensive efficiency evaluation system of energy storage by evaluating and weighing methods is established.

Can a hybrid energy storage system perform peak shaving and frequency regulation services?
