Are solar PV modules importing into the United States?

Solar photovoltaic (PV) modules are imported nto the United States in significant quantities and represent a sizable portion of installed solar capacity.

How many solar panels did the US import in 2024?

The United States imported approximately 14 billion U.S. dollarsworth of solar PV modules between January and October 2024. Almost 40 percent of these solar panels imported into the U.S. during this period came from Vietnam.

Which solar companies do not incur import tariffs?

Other "Domestic" Suppliers: A few manufacturers with U.S.-based production or assembly - such as Hanwha Qcells (Georgia factories), First Solar (Ohio), Mission Solar (Texas), and Silfab (Washington) - do not incur these import tariffs on their U.S.-made panels. They have an effective price advantage now.

How will April tariffs affect inverters & solar panels?

Overall, while the solar panel price spike is the most pronounced effect of the April tariffs, inverters are seeing a noticeable cost increaseas well, on the order of a few cents per watt.

What happened to PV module imports in 2023?

After experiencing significant growthin 2023, imports from South Korea and India have slowed, although they still collectively accounted for 15% of module imports in 2023 and 8% of imports in Q1 2024. Looking historically, import levels had decreased after the withhold release order (WRO) on PV cells and modules was announced in late Q2 2021.

When did solar PV tariffs start?

The International Trade Commission (ITC) instituted the cases for solar PV tariffs in May 2017after two global solar manufacturers headquartered in the United States, Suniva and Solar World, petitioned for import relief through Section 201 of the Trade Act of 1974.
